Appendix A (Revised 12-04-2019)

Act	The Georgia Lottery for Education Act, §50-27-1 through §50-27-55 of the Official Code of Georgia.
Activated Pack	The status of a pack of Instant Tickets which indicates to the GLC that Tickets are being sold from that Pack and a condition precedent to making Instant Tickets available for sale.
Board	The board of directors of the GLC.
Breakage	The funds resulting from the rounding of On-Line Game prizes in accordance with the respective On-Line Games Prize Structures.
Bonus Ball	The Bonus Ball feature for a drawing will use a separate ball hopper. After the standard numbers drawing, a ball will be drawn from the additional hopper. When a white ball is drawn, it will not be returned to the ball hopper. When a color ball is drawn a fixed payout will be awarded to winning tickets.
Canceled Ticket	A Ticket voided through the On-Line Game system by the selling Retailer.
Caption	The letters appearing below the Play Symbols in the play area of an Instant Ticket that verify the correctness of the Play Symbols.
CASH POP	A one (1) number out fifteen (15) possible numbers fixed prize payout draw game.
CEO	The Chief Executive Officer of Georgia Lottery Corporation.
Certificate of Authority	The non-transferable display certificate with a unique Retailer identification number assigned by the GLC for each Retailer location. The Act requires every Retailer to post this certificate and keep it conspicuously displayed in a location on the premises of the Retailer's place of business which is accessible to the public.
Claim Form	The printed form authorized by the GLC that a player shall complete and submit to the GLC along with a winning Ticket to be eligible to collect a prize.
Claimant	A player who has submitted a valid claim for payment within the required time frame.
Commission	Compensation paid to Retailers by the GLC.
Corporate Retailer Account	A Lottery Retailer that operated multiple Retailer Business Locations (generally including all Lottery Retailer accounts consisting of ten (10) or more Retailer Business Locations.
Corporation	The Georgia Lottery Corporation or the GLC.
Debt Setoff	Amounts authorized to be withheld by the GLC from payments for winning lottery prizes in accordance with Article 2 of the Act. Such amounts shall include taxes due the state; delinquent child support; and all other judgments and liens in order of the date entered or perfected.
District Office	A Georgia Lottery Corporation office in various cities in Georgia.

Double Draw	The Double Draw feature for a drawing will use a separate ball hopper. After the standard numbers drawing, a ball will be drawn from the additional hopper. When a white ball is drawn, it shall be returned to the ball hopper. When a color ball is drawn a second full set of numbers shall be drawn.
Draw Procedures	The written guidelines approved by the CEO that specify the draw procedures for a particular Instant Game, if a drawing is designed as part of the game, and for each On-Line Game.
Drawing Game	Same as On-Line Game.
Electronic Funds Transfer (EFT)	The process by which the GLC transfers funds, including Lottery Proceeds, from its Retailers, and others, to pay amounts due the GLC. Retailers provide authorization to the GLC to allow funds to be removed from a separate lottery bank account.
End of Game	The official date established by the GLC after which the playing public has ninety (90) days to claim their winning Instant Tickets.
Financial Security Deposit (FSD)	A surety bond, security deposit, irrevocable standby letter of credit, or other credit enhancement acceptable to the GLC and required of a Retailer by the GLC.
Game Number	The number on the back of each Instant Ticket which refers to the number associated with the particular Instant Game.
Game Procedures	The written rules, regulations, procedures, instructions and directives approved by the CEO, or his/her designee, that may include, among other things, the game name, how a prize is won, game Prize Structure, Play Style, and eligibility for a drawing, if any.
GLC	Georgia Lottery Corporation.

On-Line Game	A lottery game developed and offered for sale to the public where Tickets are produced by on-line Lottery Terminals, or by a Card Transaction. Players win by matching their numbers to those produced during regularly scheduled random drawings, or by other methods set forth in the On-Line Game rules for each respective game.
Pack	A package of Instant Tickets each with a different Ticket Number. The number of tickets in a pack may range up to six hundred (600) tickets, or such other amount as may be established by the CEO for a specific game. All Packs of Tickets of a specific game will have the same number of Tickets per Pack in accordance with the game's Working Papers.
Pack Number	The unique number on the back of the Ticket that designates the number of the Pack from which the Ticket originates. Each Pack Number is unique within each Instant Game.
Panel	The requisite numbers and the associated letter which constitute a single game panel on a Play Slip for an On-Line Game.
Play	A selection of requisite numbers, play types, and draws by the player to evidence participation in an On-Line Game, or other methods or actions by the player to evidence participation in an On-Line Game as set forth in the On-Line Game rules for each respective game.
Play Area	The covered area of an Instant Ticket that contains the Play Symbols.
Play Slip	A preformatted card used with On-Line Games to provide the requisite numbers selected by a player for participation in On-Line Game draws.
Play Style	The method of play to determine a winner for an individual lottery game.
Play Symbol	The printed data under the covered area on the front of an Instant Ticket that is used to determine eligibility for a prize. The Play Symbols for individual Instant Games will be specified in individual Game Procedures.
Prize Structure	The number, value, and odds of winning prizes for an individual game, as approved by the CEO, or his/her designee.
Quik Pik	A randomly generated computer selection of the requisite numbers for a player to participate in On-Line Game draws.
Retailer Advisory Board	A group of ten (10) lottery Retailers appointed by the chairperson of the Board to perform an advisory role representing the Retailers generally in accordance with \$50-27-6 of the Act.
Retailer Business Location	Each respective location listed in the Retailer Contract from which the Retailer may sell lottery Tickets and handle Card Transactions only for those specific GLC lottery transactions and games authorized for each such location by the GLC.
Retailer Contract	The annually renewable contract with the GLC required by the Act whereby a Retailer agrees to comply with and be bound by the Act, and Rules and Regulations, as may be amended from time to time.
Retailer Validation Code	The small letters found under the covered area over the Play Symbols on the front of an Instant Ticket which the Lottery Retailer uses to verify and validate Low- Tier Prize winners.
Retailer Verification Code	A boxed four (4) digit number used by the Retailer when validating Instant Tickets on a Lottery Terminal.
Settled Pack	The status of a Pack of Tickets which enables the GLC to bill (or settle) the Retailer's account based upon a pre-determined formula or schedule.

Share	As defined in the Act, any valid tangible or intangible evidence of participation in a lottery game, including Tickets and Card Transactions.
Ticket	As defined in the Act, any valid tangible evidence approved by the GLC and distributed by its Retailers, to allow participation in a game or activity authorized by the Act.
Ticket Number	The number on the back of an Instant Ticket that refers to the Ticket sequence within the Pack.
Valid Ticket	A Ticket which meets all specifications and validation requirements.
Validation Number	The unique data printed on a Ticket that provides for the verification of the Ticket as a valid winner.
Variant	A term used in conjunction with certain Instant Game Play Styles and may include a Play Symbol that serves as a "wild card" to complete a winning set of Play Symbols.
Vendor	As defined in the Act, an entity that provides or proposes to provide goods or services to the GLC pursuant to a major procurement contract.
Verification Code	Same as Retailer Verification Code.
Winner Claim Form	Same as Claim Form.
Working Papers	For each Instant Game, a detailed set of specifications designating the appearance of the Instant Tickets, the Instant Ticket delivery time requirements, and Prize Structure for the Instant Game. Upon final agreement of all specifications by both the GLC and the Vendor, the Working Papers are signed as a firm order for the lottery game to be produced according to such specifications.
